Dear Colleagues and Friends,

As we begin this new year, I wanted to take a moment to introduce myself, share a few reflections from Higher EDge, and talk about the exciting opportunities I see on the horizon.

The recent Higher EDge conference brought together an extraordinary array of voices—students, educators, and experts from across the state and beyond. For me, a key takeaway from the conference was the urgent need to create solutions that match the scope and scale of Texas itself. Looking Back to 2024 & Ahead to 2025

2024 was another noteworthy year for the partnership between the Texas Higher Education Foundation and the Texas Higher Education Coordinating Board.

Here's a look back at some of the work THEF supported to further key agency priorities. Thanks to our partners, THEF was able to provide essential support for each of these initiatives, illustrating the role private funds play in amplifying the impact of public investments. We'll also look ahead at what lies ahead for this work in 2025 and beyond!

My Texas Future

Philanthropic funding catalyzed public dollars to support the design and marketing for <u>the My Texas Future (MTF) tool.</u> The initial rollout focused on engaging a population essential to our state's workforce talent pipeline, adult learners. The latest iteration connects K-12 learners and families to higher education.

In 2025, philanthropic funding will support work to further streamline admissions through tools housed within MTF.





Direct Admissions

In October 2024, THECB launched Phase One of Direct Admissions, a functionality within MTF, entirely through philanthropic support. The functionality enables students to enter self-reported data to quickly and easily find out where they qualify for admission at universities across Texas. Some of the highlights of the Phase One rollout include:



31 of 34 four-year public institutions in Texas participated in the launch



Over 8,000 students have opted in to Direct Admissions in My Texas Future



Informing 18,000+ K-12 educators through TX OnCourse

Planning is underway for Direct Admissions Phase Two, which will focus on utilizing key administrative data, such as class rank and grade point average, to further streamline admissions. Additionally, we aim to connect students with financial aid options. To learn more, check out the Higher EDge panel, Breaking Barriers through Admissions Redesign.

Texans' Perceptions of Higher Education

To ensure My Texas Future meets users' needs, THEF supported market research with 800 Texas parents and students to learn more about their perceptions of higher education's values, benefits, and the anxieties, challenges, and motivations associated with these pursuits. Among the insights we learned, we were particularly encouraged by:

The overwhelming majority, 80% of students and parents, agree that higher education is crucial for career success.

This finding echoes what we heard from our Higher EDge student panel and underscores the importance of a continued commitment to strengthening connections between higher education and the workforce. How important is higher education in determining future career success?
